Introduction 簡介

The HKICPA Accounting and Business Management Case Competition 2021-22 aims to develop the ability of senior secondary school students, especially those studying Business, Accounting and Financial Studies, in using accounting information for business development and to improve their enabling skills as required by today's business world. Since its inauguration in 2002, more than 300 secondary schools have participated in the Competition, making it one of the most popular and significant annual inter-school events of its kind.

The Competition's success is mainly due to its use of cases for students to apply textbook knowledge to the real business world. There are three levels of the Competition to help train students' different skillsets and prepare themselves to be a future CPA.

LEVEL 1第一級別

Financial and business management analysis

- Individual or team basis (2-5 members and all team members must study at the same school but can be from different levels).
- No limit on the number of participating teams / students.
- Submit a financial and business management analysis either
 English of 4 to 6 pages or Chinese of 3 to 4 pages to assess the performance of Bonjour.

- Submit a business proposal either English of 10 to 17 pages or Chinese of 8 to 14 pages, propose recommendations on strategies to sustain the business growth of Bonjour.

- Six shortlisted outstanding performance teams from Level 2 to give a 15-minute oral presentation to the adjudicators on the key points covered in their business proposal.
- The oral presentation can be in English or Chinese, depending on the language of their proposal.

- Prizes are not transferable.
- All answers/business proposals must be original work and property of the participating students; students are strictly prohibited from reproducing or copying the answers and work of others, and have to ensure no infringement of any third party's copyright.
- · All entries, answers/business proposals must be submitted on or before the closing date specified above.
- · All students who submitted the business proposals and are selected for the final competition are required to attend the oral presentation in person.
- · By registering for the Competition, all participants will be deemed to have accepted and be bound by the rules of the Competition.
- All the finalists and winners must give consent to the Institute to the use of his/her name, photograph and presentation materials for publicity purposes.
- The Institute will invite a Principal of secondary school to be one of the adjudicators for the Competition. If one of the finalist teams is from that school, a replacing adjudicator will be arranged to ensure a fair judgment.
- The Institute reserves the right to decide on the terms, final results of the Competition and to amend the Competition rules at any time without prior notice.

Organizer 主辦機構

The Hong Kong Institute of Certified Public Accountants (the Institute) is the only body authorized by law to register and grant practising certificates to certified public accountants in Hong Kong. The Institute has more than 46,700 members and over 17,400 registered students. Members of the Institute are entitled to the description "certified public accountant" and to the designatory letters CPA.

The Institute was established on 1 January 1973. It operates under the Professional Accountants Ordinance and works in the public interest. The Institute has wide-ranging responsibilities, including assuring the quality of entry into the profession through its postgraduate CPA qualification programme, promulgating financial reporting, auditing and ethical standards in Hong Kong, and regulating and promoting efficient accounting practices in Hong Kong to safeguard its leadership as an international financial centre.

香港會計師公會(公會)是香港唯一獲法例授權負責專業會計師註冊兼頒授執業證書的組織,會員人數超過四萬六千七百,註冊學生人數超過一萬七千四百。公會會員可採用「會計師」稱銜(英文為certified public accountant,簡稱CPA)。

公會於一九七三年一月一日成立,公會根據《專業會計師條例》履行職責,以公眾利益為依歸。其廣泛職能包括開辦專業資格課程(Qualification Programme)以維持會計師的入職質素,以及頒佈香港的財務報告、審計及專業操守準則。此外,公會亦負責在香港監管和推動優良而有效的會計實務,以鞏固香港作為國際金融中心的領導地位。
